#### THE LEGISLATION OF PRIVACY: NORTH AMERICA, EUROPE, ASIA

Technology is changing how we do everything from connecting with friends to investigating our family history. Encompassing much more than simply traditional records management, information governance incorporates asset protection (the gold of the XXI century), privacy attributes, global and national electronic discovery requirements; cyber-security, storage optimization, and metadata management. Proper policies and systems enable businesses to better utilize and protect their assets; lack thereof can be devastating and impose liability that could easily become equivalent in scope to the XXI century asbestos litigation.
