7:30 - 8:30 a.m. Alternative Dispute Resolution/Business Litigation DRAFTING AND ENFORCING ARBITRATION AGREEMENTS IN A SHIFTING LANDSCAPE

Arbitration can provide a forum for businesses to avoid litigating in unfavorable jurisdictions. However, arbitration agreements, particularly in the consumer arena, are under increasing attack. For example, the Consumer Finance Protection Board ("CFPB") recently released a 728page study criticizing the use of arbitration agreements in consumer contracts. The CFPB claims that arbitration is a "rigged system" and that it can be more expensive than litigating in court. The CFPB also claims that consumers routinely win less and pay more in the arbitration setting. In light of this attack and the growing reluctance of the courts to enforce arbitration agreements, it is now more important than ever to draft enforceable arbitration agreements.

This presentation will focus on the drafting of arbitration agreements, including the potential AAA Appellate Rules, and will address alternatives to the AAA as an arbitration forum. It will also examine cases where businesses should not litigate the enforceability of arbitration agreements.

### 7:30 - 8:30 a.m. Medical Defense and Health Law/Trial Techniques and Tactics How to Use the Affordable Care Act to Challenge Damages

The impact of the Affordable Care Act (ACA) on a plaintiff's ability to recover certain damages is emerging as a major issue in personal injury litigation. Recently, a federal court in Los Angeles held that it was appropriate to consider insurance benefits available under the ACA in calculating reasonable future medical expenses. In calculating future medical expenses, the court relied on defense expert testimony regarding insurance premiums and out of pocket expenses. Ultimately, the court awarded future medical expenses of \$725,147.25 as opposed to the \$2,672,026.00 claimed in the life care plan submitted by the plaintiff. The first part of the program will be a discussion of the history of the issue, including rulings to date from across the country. The remainder of the program will feature an experienced defense attorney who will discuss how to utilize the ACA to limit a plaintiff's ability to recover damages, including the use of the ACA to combat exorbitant life care plans.

### THE NARCOTICS PROBLEM: OPIOID LITIGATION AND ITS IMPACT ON MANUFACTURERS, DISTRIBUTORS, EMPLOYERS, AND STAKEHOLDERS

This program is an expansion of a popular program from the 2015 Annual Meeting wherein Dr. Randolph focused on the over-prescription of narcotics (how the problem developed and what it does to individuals) and a defense attorney discussed how to defend a case with this component. The panelists will explore the liabilities/potential liabilities that exist along the chain of commerce – pharmaceutical companies, distributors, prescribers, pharmacists – and how to defend them.

The presentation will include a discussion of nuisance lawsuits that have been brought on behalf of governmental entities alleging wrongdoing in connection with prescription pain medications manufactured or distributed by a number of pharmaceutical defendants. In separate actions, the City of Chicago and two California counties are suing the drug industry for its "aggressive marketing" of opioid pain medications which they allege has led to an epidemic of addiction that has cost taxpayers millions of dollars in insurance claims and other healthcare costs, criminal use of the medications, and an expanded market for heroin.

Opioid abuse issues can also have a large impact on workers' comp claims. The panel will also address what pharmaceutical manufacturers, legislators, insurance companies, and other workers' comp stakeholders are doing to address the risks of opioid abuse and addiction while protecting the needs of legitimate pain patients.



### BOOK REVIEW: THE OTHER WES MOORE BY IADC OPEN FORUM SPEAKER WES MOORE

*Tuesday, July 12, 9:00 - 10:30 a.m.* In December 2000, the *Baltimore Sun* ran a small piece about Wes Moore, a local student who had just received a Rhodes Scholarship. The same paper also ran a

series of articles about four young men who had allegedly killed a police officer in a spectacularly botched armed robbery. The police were still hunting for two of the suspects who had gone on the lam, a pair of brothers. One was named Wes Moore.

Wes just couldn't shake off the unsettling coincidence, or the inkling that the two shared much more than space in the same newspaper. After following the story of the robbery, the manhunt, and the trial to its conclusion, he wrote a letter to the other Wes, now a convicted murderer serving a life sentence without the possibility of parole. His letter tentatively asked the questions that had been haunting him: *Who are you? How did this happen?* 

That letter led to a correspondence and relationship that has lasted for several years. Over dozens of letters and prison visits, Wes discovered that the other Wes had a life not unlike his own. Both had grown up in similar neighborhoods and had difficult childhoods; both were fatherless; they'd hung out on similar corners with similar crews; and both had run into trouble with the police. At each stage of their young lives, they had come across similar moments of decision, yet their choices and the people in their lives would lead them to astonishingly different destinies.
