## Information on Upcoming Elections

### **The Election Process**

Elections of new Board Members and Officers will take place at the Annual Meeting in July. 

The *Defense Counsel Training Manual* is also currently available in print and for free in PDF form for IADC members. Members can find the PDF version under the Members Only section of the IADC website.


## New Defense Counsel Journal Online
