# THE PRESENTATION:

#### Brexit: Its Roots, Growth, and Fruits

The roots of Brexit have been growing for years and, indeed, continue to grow. During this special Webinar on Brexit, IADC Past President William (Bill) Perry will discuss and answer questions about the roots of discontentment in Britain that led to the Brexit vote as well as whether or not there is any continued discontentment in Britain over the vote. Mr. Perry will discuss the implications resulting from the election of a new Prime Minister, whether or not the British Parliament will pass the necessary laws to repeal the laws that got Britain into the EU, and what steps are necessary before Britain can withdraw from the EU. Mr. Perry will also address whether or not the anticipated fruits of the vote have been seen thus far in Britain.

He acts for clients in many jurisdictions. His practice centers on insurance and reinsurance disputes and coverage issues, advice on wordings, and commercial litigation and arbitration.

Mr. Perry has been recognized by *Who's Who Legal, Chambers Guide to the UK Legal Profession*, and *Legal 500* over many years. He has been named as a Super Lawyer and one of the Top 100 Lawyers in London.

Mr. Perry is also a member of the Association of Defense Trial Attorneys.
