- Q. What is one piece of advice you received during your career that changed the way you practice?
- A. Do it carelessly if perfectionism is holding you back getting it done is better than getting it perfect.

Who is Daniel?

Daniel Higginbotham is a trial attorney at Thomas Combs & Spann PLLC in Charleston, West Virginia. He has spent more than a decade defending pharmaceutical and medical device manufacturers and has tried cases to jury in state and federal courts across the country. A member of IADC since 2018, Daniel serves as a vice-chair on the Drug, Device & Biotechnology and Engagement & Retention Committees and is also involved in the Product Liability Committee.



What are some of Daniel's insights about his journey as a litigator?

- Q. What do you know now that you wish you had known at the beginning of your legal career?
- A. I don't know everything and that's ok! Young lawyers all too often feel like they should have the answer to any and every question, on the spot. I know now—and wish I knew many years ago—that it's ok to tell a client or judge that I don't know the answer to a question and will do everything I can to figure out the answer as soon as I can. In many situations, that honest answer will build your credibility.
- Q. What opportunity has had the most significant positive impact on your legal career?
- A. When I was a young lawyer, a client who believed in me more than I believed in myself gave me an opportunity to work on several trials, first as a behind-the-scenes associate, then as appellate counsel, and then trial as counsel. I had doubts about my readiness for every one of those roles, but she insisted I could handle it. Without her mentorship and confidence, who knows where I would be in my career today.
- Q. What is one piece of advice you received during your career that changed the way you practice?

A. When clerking, I learned that you disagree with someone without being disagreeable. All too often it's considered a weakness to be pleasant toward your opponents. I believe the opposite - that the ability to maintain your emotions and professionalism when an opponent is being difficult is a tremendous asset in the practice of law.
