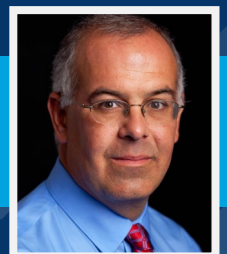

## Join Us for the 2021 Annual Meeting

**David Brooks, author and New York Times columnist**

David Brooks has a gift for bringing audiences face to face with the spirit of our times with humor, insight, and quiet passion. He is a keen observer of the American way of life and a savvy analyst of present-day politics and foreign affairs.

He holds several prestigious positions as a commentator:

- Bi-weekly Op-Ed columnist for the *New York Times*
- Regular analyst on PBS *NewsHour* and NPR's *All Things Considered*

David's *New York Times* bestseller, *The Road to Character*, "explains why selflessness leads to greater success. He tells the story of ten great lives that illustrate how character is developed, and how we can all strive to build rich inner lives, marked by humility and moral depth. In a society that emphasizes success and external achievement, *The Road to Character* is a book about inner worth." In his most recent book, *The Second Mountain: The Quest for a Moral Life* (Random House), David explores the four commitments that define a life of meaning and purpose: to a spouse and family, to a vocation, to a philosophy or faith, and to a community.

His previous book, *The Social Animal: The Hidden Sources of Love, Character and Achievement*, uses the story of a fictional American couple to explain the importance of neuroscience and sociology in understanding America's politics, culture, and future. His other books, *Bobos in Paradise* and *On Paradise Drive*, are in a style he calls "comic sociology"—descriptions of how we live and "the water we swim in" that are as witty and entertaining as they are revealing and insightful. *Bobos in Paradise* was a *New York Times* bestseller.

David is currently teaching a course at Yale University. He holds honorary degrees from Williams College, New York University, Brandeis University, Occidental College, among others. In 2010, Brooks became a member of the American Academy of Arts and Sciences. David Brooks has worked at *The Weekly Standard*, joining the magazine at its inception and serving as senior editor. He has been a contributing editor at *Newsweek* and the *Atlantic Monthly*. He worked at *The Wall Street Journal* for nine years in a range of positions, including op-ed editor.

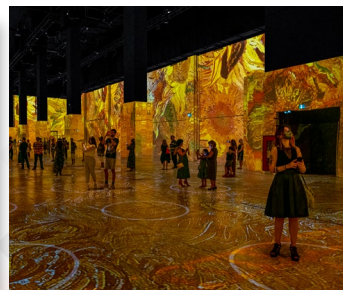

No reason for the cancellation need be provided for a timely notice of cancellation. NO CASH REFUND will be made if notice of cancellation is received by the IADC office thirty (30) days or less prior to the first day of the meeting. However, if special circumstances arise before the meeting which prevents attendance, a member may request a future meeting credit. The request needs to be in writing and submitted to the IADC office. It should be directed to the Finance Committee's attention and note the special circumstances which caused the cancellation. The credit request can only apply to meeting registration fees (not air, hotel, activity, tour, or special event fees) and, if approved, will be valid for use toward any IADC meeting for one (1) year from the date of the meeting for which credit is requested. A \$199 processing fee will be deducted from the total future meeting credit. All future meeting credit requests will be considered by the Finance Committee and the decision of that Committee will be final.
