The IADC has also established a Rule 702 Sustainability Committee, chaired by Eric Lasker. The Committee's charge is to promote and re-enforce the amendments to Rule 702 through educating the courts and fellow defense attorneys about how the rule was amended and why. The Committee was asked to (i) collect resources for use by IADC members, (ii) involve members in promoting/publishing the amended Rule and its meaning, and (iii) firmly anchor the new 702 expert admissibility standards in federal courts throughout the country and press for similar amendments to State expert admissibility rules. The Committee is hard at work on these initiatives.
