#### **Strengthening Community: Supporting Our Members**


#### 2025 Professional Liability Roundtable

#### A Statement on Diversity, Equity, and Inclusion by ADTA, DRI, FDCC, IADC, and HNBA











The IADC dedicates itself to serving and benefiting our members, the legal profession, and the civil justice system by enhancing the development of skills, professionalism, diversity, and camaraderie in the practice of law. The organization's mission includes a commitment to ensuring equal opportunity in the legal profession and creating a pipeline of future leaders in the field that reflect the diversity of the communities and clients we serve.

While there have been many statements in support of diversity issued by legal organizations in the last month, the IADC leadership and the leadership of our Sister Defense Organizations felt it was important to come together to speak with One Voice on issues that impact all of us. To that end, we collaborated and reached agreement. We then circulated our Joint Statement to other members of the American Board of Advocates Roundtable, many of whom had issued their own statements. We were pleased that the newest member of the Roundtable, the Hispanic National Bar Association wanted to join their voice with ours. The HNBA is made up of more than 78,000 lawyers, and includes judges, law students, and legal professionals. We offer the following with One Voice for the right to hear many voices.

The foundation of a just legal system is built upon the principles of equal protection under the law, civil rights, and the rule of law itself. These bedrock values ensure that every individual—regardless of race, gender, religion, ethnicity, disability, sexual orientation, political or ideological persuasion or background—is afforded the full rights and opportunities promised in the Constitution. We are all created equal; we all have the promise of inalienable rights and liberties.

Diversity, equity, and inclusion (DEI) are not merely corporate policies or social initiatives; they are essential expressions of justice and fairness, deeply embedded in our legal and moral traditions. The Civil



Rights Act of 1964, the Fourteenth Amendment's Equal Protection Clause, Americans with Disabilities Act and decades of legal precedent affirm that combating discrimination and expanding opportunities for all is not just a moral imperative, but a legal necessity. It is a fundamental value that must remain assured.

Actions that seek to curtail DEI efforts in businesses, educational institutions, and government agencies threaten to undermine these fundamental protections for all. The principles of diversity and inclusion were never about exclusion or preferential treatment; rather, they are about ensuring that every person, regardless of their identity, has a fair and equitable chance to contribute, compete, and succeed.

Opposition to DEI initiatives is often framed as a defense of meritocracy. However, true meritocracy can only exist when historical barriers to opportunity are acknowledged and addressed. The rule of law does not permit discrimination in any form, whether overt or systemic. It mandates that our institutions actively protect against inequity, just as they do against other forms of injustice. We remain committed to inclusion as it strengthens our democracy and economy. Institutions that embrace diverse perspectives perform better, innovate more, and serve a broader range of communities. More importantly, an inclusive society ensures that no one is left behind—not because of artificial constraints, but because they are empowered to realize their full potential.

As professional associations committed to justice and advancing the rule of law and equal access to legal and equitable protections, we recognize that equality before the law is not a passive principle—it is an active pursuit. Any effort to dismantle diversity initiatives under the guise of neutrality is, in effect, a step backward in the ongoing fight for civil rights. The rule of law demands that our institutions uphold fairness for all, not just for the privileged or the powerful.

We urge our leaders, lawmakers, and business communities to remain steadfast in their commitment to diversity, equity, and inclusion because it advances the rule of law, is legally sound, and is morally and ethically right.



#### A Statement Regarding Attacks on the Rule of Law

The International Association of Defense Counsel ("IADC") is an organization of highly skilled legal professionals working to benefit our profession and our civil justice systems. Rooted in our <u>mission and guided by our core values</u>, the IADC stands firmly against any attempts to undermine democracy and the rule of law.

The rule of law ensures that all individuals and institutions, including the government, are accountable under the law. It guarantees equality before the law, fair legal processes, and the protection of fundamental rights. The rule of law must not be silenced.

We condemn threats, attacks, or any rhetoric that calls for impeachment of judges simply because their decisions may be unpopular or at odds with other branches of government. Systems of government rely on the independence of the judiciary, and judicial decisions must be honored.

Lawyers must adhere to the highest ethical standards. They must be able to represent their clients without fear and to the best of their abilities. Lawyers are our clients' voices. Their voices need to be lifted freely without improper governmental interference.

We are committed to respecting the rights of every person as granted under the law, supporting the work of lawyers operating in good faith to represent their clients, and supporting the judiciary in its essential work to maintain the structure of the rule of law.

#### **AMICUS CURIAE BRIEF**

#### Amicus Curiae Brief Filed in *Dennis Speerly, Et Al. v. General Motors, LLC* (1/30/2025)

On January 30, the IADC filed an amicus brief in *Speerly v. General Motors*, an important class action case now pending before the *en banc* Sixth Circuit. The district court in *Speerly* certified twenty-six statewide classes, centering around an alleged transmission defect. A panel affirmed, taking a lax view of what Rule 23 requires before certifying a class. A few months later, a different panel of the Sixth Circuit *reversed* certification in a set of cases against Nissan, applying a stricter view of when a class may be certified. The later decision, *In re Nissan*, clarified many points of class action law, including that an issue is common only when a reasonable jury would have to resolve the issue the same way for all class members. Less than a month after *In re Nissan*, the full Sixth Circuit granted *en banc* review in *Speerly* and is poised to decide whether the lax approach or the strict approach should govern class certification decisions.

The IADC's en banc amicus brief in Speerly defends and elaborates upon the reasonable jury standard. The brief agrees with In re Nissan that an issue is individual if a reasonable jury could, based on the evidence likely to be presented at trial by both sides, answer the question "yes" for some class members and "no" for



others. A question is common, then, only if a reasonable jury would have to answer it the same way for the entire class. This standard follows from the Rules Enabling Act and the Seventh Amendment, which together protect a party's right to trial by jury on issues that admit reasonable disagreement. Because the



district court in *Speerly* applied the opposite standard—considering issues to be common when a reasonable jury *could* rule the same way for all plaintiffs, instead of when a reasonable jury must do so—the brief argues that it should be reversed.

The amicus brief was authored by Aaron Van Oort, John Rockenbach, Anderson Tuggle, and IADC member Paul Cauley, all with Faegre Drinker Biddle & Reath, LLP.
