The Foundation of the IADC Announces 2015 Foundation Forum Speaker



The Foundation of the IADC is pleased to announce Doris Kearns Goodwin as its 2015 Foundation Forum speaker. Goodwin will speak on "Leadership Lessons of History: Doris Kearns Goodwin on the American Presidents" at the IADC Midyear Meeting in Marco Island, Florida on Sunday, February 15.

Doris Kearns Goodwin is a world-renowned presidential historian and Pulitzer Prize-winning author.

Goodwin is the author of six critically acclaimed and *New York Times* best-selling books, including her most recent, *The Bully Pulpit: Theodore Roosevelt, William Howard Taft, and the Golden Age of Journalism* (November, 2013). *The Bully Pulpit* is a dynamic history of the first decade of the Progressive era, that tumultuous time when the nation was coming unseamed and reform was in the air. Steven Spielberg's DreamWorks Studios has acquired the film rights to the book.

Spielberg and Goodwin previously worked together on *Lincoln*, based in part on Goodwin's award-winning *Team of Rivals: The Political Genius of Abraham Lincoln*, an epic tome that illuminates Lincoln's political genius, as the one-term congressman and prairie lawyer rises from obscurity to prevail over three gifted rivals of national reputation to become president.

The film *Lincoln* grossed \$275 million at the box office and earned 12 Academy Award® nominations, including an Academy Award for actor Daniel Day-Lewis for his portrayal of President Abraham Lincoln.

Goodwin was awarded the Pulitzer Prize in history for No Ordinary Time: Franklin and Eleanor Roosevelt: The Home Front in World War II, and is the author of the best sellers Wait Till Next Year, Lyndon Johnson and the American Dream and The Fitzgeralds and the Kennedys, which was adapted into an award-winning five-part TV mini-series.

Goodwin earned a Ph.D. in Government from Harvard University, where she taught Government, including a course on the American Presidency. She served as an assistant to President Lyndon Johnson in his last year in the White House, and later assisted President Johnson in the preparation of his memoirs. Goodwin is the winner of the Charles Frankel Prize, given by the National Endowment for the Humanities, the Sarah Josepha Hale medal and the Lincoln Prize.

Goodwin resides in Concord, Massachusetts, with her husband, the writer, presidential advisor, speechwriter and playwright Richard N. Goodwin. She was the first woman to enter the Boston Red Sox locker room, and is a devoted fan of the World Series-winning team.

Brilliant demonstrations were given on opening and closing arguments, and direct and cross examinations of expert and lay witnesses. Faculty and students enjoyed learning from each other and getting to know other trial lawyers.

Students were impressed by just how close the week came to creating the atmosphere surrounding a real trial. By day four, everyone began to feel the effects of sleeping very little, performing a specific element of trial each day, and networking in the evening between preparation periods for the next day's exercises. However, everyone felt that the investment of their time and energy was paying great dividends in sharpening their trial skills. One Trial Academy student said, "I thought the entire Trial Academy experience was exceptional - both in the instruction and the people that I had to opportunity to meet. I'm still adjusting back to Eastern time, but that, the hard work, and the time away were all well worth it."




