INFORMATION ON UPCOMING ELECTIONS

The Election Process

Elections of new Board Members and Officers will take place at the Annual Meeting in July. Per our bylaws, any Member in good standing is eligible for nomination and election to any elective office in the IADC. At the Annual Meeting Closing Session, a Nominating Committee appointed by the President will report to the Association with its nominations to fill the following positions: President-Elect, Vice President of Insurance, and three new Board members. Additional nominations for these offices may be made from the floor at that time provided that the intention to make such a nomination, identifying the intended candidate(s), shall have been given to the Secretary no later than the Opening Session of the Annual Meeting. Information on how to submit testimony to the Nominating Committee will be published in the June IADC *Docket*. You can either provide comments onsite at the Annual Meeting or in writing prior to the meeting. The IADC will publish biographies in June of any member who wishes to be considered for the office of President-Elect. Please inform President Tripp Haston (thaston@babco.com or 1.205.521.8303) no later than Monday, April 20, 2015 if you wish to be considered for this position and want your biography published in June with the election materials.

Prohibitions on Campaigning

The IADC's policy is to prohibit public or private campaigning for a position on the Board of Directors or as an Officer. Members should not campaign on behalf of anyone whom they are supporting for a position on the Board or as an Officer.

Participate in the Process

We encourage all members to participate in the process. When providing comments to the Nominating Committee, you can comment on one open position or all open positions. If you don't have a particular member to endorse for the Board but want to offer input on the direction our leadership can go, you can do that as well.

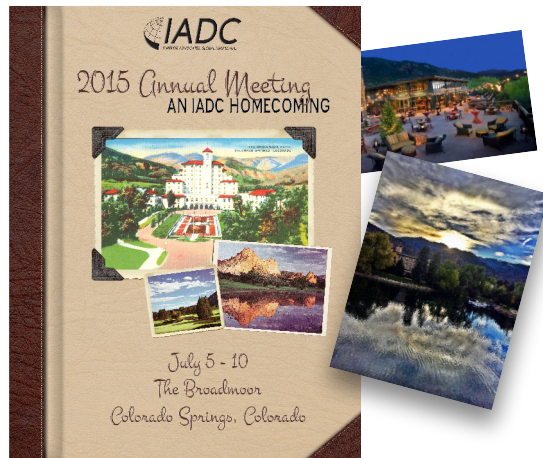

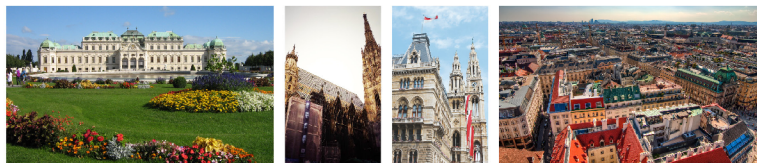
